

## Umbrella Prime® (05/06 Edition)

### Overview

### Product Enhancement Highlights

- ◆ Mandatory endorsements have been incorporated and no longer need to be attached:
  - 83864 (02/04)—Miscellaneous Changes Endorsement
  - 87068 (11/04)—Economic or Trade Sanctions Conditions Endorsement (OFAC)
  - 87241 (12/04)—Violation of Communication or Information Law Exclusion Endorsement
- ◆ The following ISO changes from the 2004 GL form have also been incorporated:
  - ISO Mobile Equipment Definition
  - ISO Electronic Data Exclusion
  - ISO Pollution Exclusion
- ◆ Claims Address—Information now includes fax number and email address
- ◆ Contractual Liability—The words "and prior to the termination" were deleted

- ◆ Approved in all jurisdictions where Umbrella Prime (10/04 Edition) is approved (Not approved in Alaska, Florida, Louisiana, New York, Vermont, Virginia and Washington. Umbrella Prime (05/06 Edition) may be used in the New York Free Trade Zone)
- ◆ Includes CrisisResponse® Coverage that gives insureds access to funds to assist when managing a crisis

### Submission Requirements

- ◆ Any completed and signed commercial umbrella application is accepted
- ◆ Primary insurers must have A.M. Best rating A- VII or better, or be a qualified Self Insurer
- ◆ Minimum 5 years currently valued loss experience
