TradEnable Portal Overview and Logging In



AIG's new TradEnable system allows Brokers and Policy Holders to administer and track policy activity via the **TradEnable Portal**. Initial functionality includes the ability to add new Buyers to an existing policy, request new limits for an existing Buyer, and cancel existing limits.

The Portal also provides the facility of creating and managing Users within your organization. Once your user profile has been created you will also be able to access the portal directly via one of the following browsers:

The Portal has been designed with two-factor authentication to ensure security of policy information across the Internet. The authentication code will be sent to the same email address as your initial user name and temporary password notification.

Initial access to the Portal

You can request access to the Portal from your organization's TradEnable AIG Trade Cred contact, or from your contact in AIG. Once your user profile has been created you will receive an email with username and a temporary password. When you follow the link in the confirmation email, you will need to set a permanent password before using the Portal. 
